Important Information

- Applicants may download the prospectus from the college website , www.avcollege.ac.in
- Fee structure for M. Sc. in Mathematics and Chemistry are as mentioned in the prospectus.
- Applicants have to fill the form and submit it online in the college online portal.
- *The fee waiver scheme will be applicable for M. Sc. in Mathematics as per Assam Government order. However, the fee of M. Sc. in Chemistry will not be covered by fee waiver scheme as it is self financed course.*
- Admission will be strictly on the basis of merit list declared by Gauhati University.
- Admission will be done at college premises on the day of admission mentioned in the admission schedule . Payment has to be made in online mode using Debit card/Credit card/Net banking or other available options. Therefore candidates are advised to ensure proper functioning of online payment options.
- Reservation policy will be followed as per the Government rule. The supporting document has to be issued only by the competent authority under the Government of Assam.
- **Documents to be uploaded:**
 1. A passport size photograph
 2. Caste Certificate
 3. Mark sheet of latest TDC Semester examination whose result has been declared (4th/5th/6th Semester)
 4. Income certificate if any
 5. EWS certificate if any.
- All the relevant original documents will be physically verified on the date of admission. If any information provided by the applicant is found to be false during verification, his/her admission will not be granted.

FEE WAIVER SCHEME : (Applicable only for M. Sc. in Mathematics)

- As per Government Notification vide [No. PC/HE/Misc/42/2020/235](#) dated 29th June 2022 and [No. PC/HE/Misc/42/2020/51](#) dated 6th September 2021, fee waiver is applicable for admission for the session 2022-23 under Pragyani Bharti scheme.
- For availing fee waiver, annual parental income should be less than Rs. 2.00 lakh from all sources.
- If either parent (mother or father) of the student is working in the state Govt./Semi Govt./State or Central Govt. Undertakings, such students cannot avail the fee waiver scheme.
- *Candidates seeking fee waiver must report to the office of the principal, Arya Vidyapeeth College with the following documents (i) original Marksheet, (ii) income certificate from the local Revenue circle officer, (iii) A declaration from the students that neither of the parents (father or mother) is an employee of State /Central Govt. Department or its undertaking, (iv) photograph of sapling plantation at his/her college or home.*
- After fee waiver grant by the college admission committee, the candidate has to pay the required amount of fee not covered under the fee waiver scheme.
- Candidates who are not allowed by the admission committee of the college for fee waiver, can take admission by paying the normal admission fee.
- The decision of the college regarding fee waiver will be considered final and binding.
